e) Grant Applications Received – 1st Goxhill and Barrow Scouts, Barton Food Bank

In view of both applications not providing evidence that funds are immediately required it was agreed that the committee should not commit funds from next year’s budget at this time. Cllr Vickers requested a letter of support being forwarded to both applicants.

Barton Upon Humber Food Bank application should re-submit when the outcome of their planning application is known.

296. **To consider how best to fund future initiatives including employment of the Handy Person, the outcome of the Staffing Review and WC cleaning at the Interchange**
